Anyone may request a hospice evaluation. Consider speaking with a hospice admissions nurse for information and advice. With your permission, the nurse will contact your physicians and make arrangements for a visit to evaluate your specific situation.

## KNOW YOUR HOSPICE BENEFITS

### Durable Medical Equipment (DME) and Supplies

In addition to respite care and medications, below are some examples of durable medical equipment and supplies which may be covered by the Medicare hospice benefit and provided by your hospice team, if needed.

- Alternating Pressure and/or Low Air Loss Mattress
- Bed alarm
- Bedside commode
- Catheters
- Disposable gloves
- Nutritional drinks/meal supplements
- Fall mats for patients who are at risk of falling
- Hospital bed
- Hoyer Lift
- Incontinence protection and undergarments
- Mouth moistening swabs
- Narcotics lock box
- Oxygen tank and tank refills
- Safety rails and pads
- Specialty bed
- Trach care supplies & equipment
- Walkers
- Wheelchair
- Wound care supplies
